Cost Proposal:

Detailed breakdown of costs including licensing, implementation, training, and support. Optional and additional services costs. The proposal must also include any associated fee for importing data from our current software vendor.

Compliance:

Documentation demonstrating compliance with Michigan and federal reporting standards.
